

## Notarized Request for Personal Driving and Motor Vehicle Information

In accordance with s. 33(c) of the Freedom of Information and Protection of Privacy Act, the Traffic Safety Act, and the Access to Motor Vehicle Information Regulation, specific personal information is collected to determine the recipient's authority to request the information and to confirm the identity of the recipient and of the authorized employee of the recipient (if the recipient is an organization). The registry agent stores the documents for one year. The form is used to monitor and audit the release of information and to conduct investigations if the Registrar receives complaints about the release. Alternatively, questions may be mailed to Box 3140, Edmonton, AB TSJ 2G7, attention Data Access and Confract Management Unit (DACMU).

This form is for use by a person who is out of province and cannot be present in the office of a registry agent and who cannot be represented by a personally known individual, and requires the release of his/her personal driving and motor vehicle information.

NOTE: This application and the copies of the notarized documents you provide are valid only for one month from the date of notarization.
